Hartman, Rosenthal rally for Red Ribbon victory

Before Tuesday, Andrew Rosenthal of New York had never won a pair game, even Flight C. He couldn't have picked a better time to win his first -- the Red Ribbon Pairs championship he captured with Jennifer-Jo Hartsman.

Hartsman, of Spokane WA, and Rosenthal moved into position to win with a 65% first final session and came through with just enough in the second final to eke out victory by less than one matchpoint.

Second place went to Martin Hunter and Andy Stark of Mississauga ON, the leaders after two qualifying sessions.

The winners' score of 2591.65 was .93 better than

Assini does it again: another Wagar upset

Midnight still hasn't chimed in the Wagar Women's Knockout Teams for the Cinderella squad captained by Jan Assini. After knocking out the top-seeded team on Monday, Assini and company rallied in the fourth quarter Tuesday for another upset, this time over the Judi Radin sextet, 128-122.

Assini, of Aurora OH, is playing with Laurie Kranyak, Bay Village OH; Sharon Jabbour and Susan Miller, Boca Raton FL; Mary Oshlag, Germantown TN, and Candace Fowler, Jacksonville FL.

In the semifinal round today, the Assini team will face the No. 4 seed -- Shawn Quinn, Katy TX; Petra Hamman, Peggy Sutherlin and Joan Jackson, Dallas; Robin Klar, Spring TX, and Mildred Breed, Bryan TX. They defeated the Lynn Baker squad, 185-152.

The other semifinal match pits Karen Allison (npc) against Cheri Bjerkan.

Assini trailed Radin, 86-55, at the half but were within 14 IMPs with a quarter to go. They won the final set, 41-21, to pull out the victory.

More upsets as Spingold enters round of sixteen

One top seed is out and two others had close calls in a day of wild action in the Spingold Knockout Teams.

On the sidelines as play enters the round of 16 today is the four-man squad captained by Jimmy Cayne, the No. 2 seed. They were eliminated by Joe Jabon, Bellevue WA; Aidan Ballantyne, Vancouver BC, and Henry Lortz and Wayne Ohlrich of Seattle.

Women, bidding, behavior different today — Stakgold

Ivar Stakgold, one of the brightest stars in the ACBL firmament back in the Fifties and Sixties, is back at the table again. He has noticed quite a few differences from the old days.

Women players. "Women players are different -- they're not wimpy the way they used to be. Back then the only women we had to worry were people like Helen Sobel and Edith Kemp. Now almost any woman you play against can hurt you."

Behavior. "Today's players are much better behaved. There's very little of that shouting and screaming that used to dominate the game back then."

Bidding. "Players today know competitive bidding. This makes the game somewhat wilder -- definitely more interesting. However, I don't

Swiss Team inventor wins Sr. Swiss Teams

The man who invented Swiss Teams now is a North American Swiss Team champion. Marc Low of Centerville OH was a member of the sextet that sealed their triumph with a powerful victory over the defending champions in the Senior Swiss Teams. Playing with Marc were his wife Sandy, Corinne and Jim Kirkham of San Bernardino CA, Richard Potter of Black Mountain NC and his brother John Potter of Panama City FL.

The Kirkham team led the defenders, captained by Mike Levine of Boca Raton FL, by 5 Victory Points going into the last match. The winners played strongly throughout those seven boards to win going away while knocking the defenders down to fourth place.

The runners-up were Jim Barrow, Ed Lewis, James Murphy, David Adams, Randy Pettit and Allan Siebert.

What's this about inventing Swiss Teams? Back in the Sixties, most bridge players were getting tired of board-a-match teams -- the same teams were winning week after week. Attendance would be fine on Saturday for the Open Pairs, but would dwindle, often to single digits, on Sunday for the board-a-match game.

Low had an idea, but he had trouble being heard. Finally he convinced Carl Rubin, a member of the Board of Directors, to let him try his idea at a sectional in Cincinnati. It was an instant success. Within less than two years, board-a-match almost disappeared and Swiss became so popular that sometimes more people played on Sunday than on Saturday.

Marc's wife Sandy says she's been trying to help him win a North American Swiss to celebrate his invention, and that dream finally has come true. Just to make sure things went right, Sandy wore her lucky outfit -- the ensemble she wore when she won a recent knockout teams.

Too tough

What can you do when your opponents make simply great bids? All you *can* do is pay off in IMPs, sometimes heavily. For an example, observe Brad Moss in action on this deal from the second round of the Spingold Knockout Teams. Moss, of New York City, was playing with Fred Gitelman of Toronto.

Moss held

♠K Q J 8 ♥K Q J 9 ♦A 7 ♣9 3 2

and heard the bidding go 1♣ on his left, double by his partner. Moss bid 2♣, of course, heard 3♣ on his left and 3♥ from partner. Now RHO got involved with a bid of 4♣. What would you do?

Moss bid 4NT, Roman Key Card Blackwood for hearts, found two aces in partner's hand -- and bid 6♠! Moss knew that his partner was a favorite to hold five hearts, and with a minimum and 3-5 in the majors, Gitelman would have overcalled 1♥ rather than doubling. Gitelman's likely shape, therefore, was 4-5-3-1, and so it proved. The full deal:

6♥, the contract at the other table, has no play, but 6♠ can be defeated only on the lead of a low heart. Declarer must ruff clubs to make his slam, and when West comes in with a club after a heart lead, he can give his partner a ruff. In 6♠ on the lead of a high club, declarer can maneuver to ruff two clubs in dummy to get home with 12 tricks: five hearts, one diamond, four spade tricks by South and two club ruffs in the North hand. Plus 1430 was a 17-IMP gain.

Goodwill Message

Only bridge offers a new player and a world champion the same opportunity -- winning a bridge championship.

It's true that only a limited number of titles can be won but we can all be winners in terms of goodwill.

A real deja vu

At the International Team Trials in Memphis, a pair had a misunderstanding about 4♦ when it was intended as asking for key cards with diamonds as the key suit. As a result they made a diamond slam that should have been beaten against Chip Martel's teammates.

Then in Monday's Spingold loss, Martel's opponents had a misunderstanding about 4♦ when it was intended as asking for key cards with diamonds as the key suit. Once again the result was a diamond slam bid and made against Martel. This result swung 21 IMPs, the exact margin by which Martel's team lost.

This was the Team Trials deal.

Michael Rosenberg led the ♣10, taken with the jack, and Ralph Katz attacked trumps, leading the king. Rosenberg followed with the ♣9, which Rosenberg intended as showing interest in spades. Next Katz overtook the ♣Q with the king. He cashed the ♣A, pitching a heart, then led the ♠J. Zia rose with the ace, and that was the end of the defense. Katz was able to ruff out the ♠K and get a heart pitch on the ♠Q for his slam.

Zia had to duck the ♠J and let his partner win the trick to beat the contract. He also could have returned a heart at trick three instead of a club. Since the contract was 5♦, just making, at the other table, Martel's team lost 11 IMPs instead of winning 10 -- a 21-IMP swing at an important point in the match.

Justin's chance

In the second quarter of their Spingold Knockout Teams match against the Hemant Lall squad, John Sutherlin and Russ Ekeblad were playing against Jan Lall and Susan Clemmons.

The Ekeblad team includes George Steiner, Gaylor Kastle and French world champions Christian Mari and Paul Chemla.

There was a lull in the action at Sutherlin's table, and 12-year-old Justin Lall, a member of his dad's team, rushed up.

"Mom," Justin said breathlessly, "we have the seed in the third quarter. I want Chemla!"

the correct bid is 5♣.

If the final contract had been 5♦, chances are very strong that Stansby would have led his singleton spade, counting on partner to have either the ♠A or the ♦A. This would beat the game two tricks -- ♠A, spade ruff, ♥A, spade ruff.

But David Gurvich bid 6♦ even though he knew his side was off two key cards -- he hoped he wasn't off two aces. And there was no way for Stansby to know that declarer was missing two aces -- he of course believed his partner held only one ace. He thought it was important to set up a trick while partner still had his ace, so he led a club. Curtains!

Gurvich won the ♣A and then quickly played the ♣K to get rid of his losing heart. He still had to worry about spades, but that became easy when the queen showed up singleton.

At the other table Martel's teammates bid 3NT and made an overtrick for a 10-IMP loss. If Stansby and Martel had beaten the slam they would have gained 11 IMPs -- a 21-IMP swing and enough to tie the match.

Well-considered endplay

Michael Levine of Boca Raton FL, a member of the defending champions in the Senior Swiss Teams, found a neat play to make a major gain in one of yesterday's matches in the Senior Swiss final.

West opened the ♣3 to the ace, and Levine played ♦K, ♦A, diamond ruff. He ruffed his other club and cashed the ace of trumps. A second trump put West on lead, and he got out with the ♦Q, ruffed. Levine knew West didn't have both club honors -- he would have led one of them. So what did he have for his double of the opening bid? He had seven HCP in the red suits and two or three in clubs. So Levine decided West probably had both the king and jack of spades. He led away from his spade honors and West was fixed. He won his jack, but then he either had to lead away from his ♠K or lead a club and give Levine a sluff-ruff.

Message received

You are playing in the opening round of the Spingold Knockout Teams, and you pick up this hand:
 ♠9 6 2 ♥8 6 4 ♦J 10 7 3 ♣9 5 4.

Your right-hand opponent opens 1♠, you pass, and left-hand opponent bids 4NT (Roman Key Card Blackwood). Partner passes and RHO responds 5♥ (two key cards). You pass again and LHO bids 7♣, which partner doubles (!). What is your lead? Think carefully -- 31 IMPs are riding on your decision. The auction again:

Make your choice before you read on.

Bernie Miller was East in this nerve-racking scenario, and he felt that he had a chance to tilt the odds in his favor by doubling the grand slam. All Miller needed was for his partner, Lou Finkel, to come through.

Miller figured North had some problem counting key cards, but he could see that cashing the ace might not be so easy. After all, partner in this auction would not normally be trying to find you with an ace.

Miller doubled the grand slam in the hope that partner would read it as a Lightner double and lead his long suit -- if Finkel read the double as lead-directing, he might think Miller was void somewhere and therefore lead the suit in which he had the greatest length.

By thus eliminating trumps -- the Lightner double says *do not* lead a trump -- and clubs (Miller's seven-card holding in that suit made it likely Finkel didn't have length there), Miller improved his chances by 50%. Indeed, Finkel found the correct lead -- a diamond -- and it was his longest suit. The full deal:

Freed, Robison seek second IMP Pairs title

Gene Freed and Jim Robison, who won the IMP Pairs in Chicago last summer, are seeking to become the first repeat winners in the event's 12-year history.

If they succeed, Freed would become a three-time winner. He won in 1988 with Mike Passell.

Freed and Robison were not among the leaders after the two-session qualifier, but they jumped to the forefront of the 182-pair final to emerge with the win in the last round. This deal from the first final session was key:

Freed decided that his hand was too good for a simple 2♥ overcall, so he started with a double. Robison dredged up a 3♣ bid over North's non-forcing 2♦ but made a good decision to bid 3NT over Freed's 3♥.

If Robison had passed 3♥, certainly possible with his sketchy values and lack of fit, the pair was headed for a minus score. The defenders would take two spades, two diamonds and a heart.

As it was, 3NT was cold -- provided East is the declarer. 3NT by West can be defeated by an initial spade lead and a diamond shift by South for a spade continuation.

Lebhar Trophy

Players will compete for the Lebhar Trophy, donated by Bertram Lebhar Jr. in 1948 in memory of his wife Evelyn. The trophy was previously given to winners of the Mixed Teams but re-designated for the IMP Pairs by the ACBL Board of Directors.

Lebhar (1907-1972), under the name of Bert Lee, earned a national reputation as a sportscaster and later as a bridge player and administrator. In private life, he owned radio and television stations in Florida.

Perhaps his greatest achievement arose from his work as ACBL treasurer from 1945 to 1947 and as a member of the Steering Committee.

In the late Forties, Lebhar was instrumental in the modernization of ACBL. He was perhaps the first to visualize ACBL's vast potential for expansion. His farsighted efforts were recognized when he was named *ACBL Honorary Member* in 1963.

Lebhar was one of the founders of the Greater New York Bridge Association and was elected its first president in 1948.

Lebhar was also a player: he won the Spingold in 1940 and the Master Mixed Teams in 1946. His team was his wife Evelyn along with Samuel Katz and Alicia Kemper.

As you can see, a club lead and continuation will sink the contract, but who would even think of doing so after this auction?

West led the ♦10, and Shenkin read it as a doubleton, meaning East had seven diamonds. Shenkin took East's ♦K with the ace, cashed the ♥A and then abandoned trumps. He ran four rounds of spades, discarding a club loser to bring home his game. Ten tricks made!

Note that if Shenkin had taken the trump finesse, West would have been likely to find the club switch and defeat the contract.

Ehrlichman's squad features two 18-year-olds -- Ari Greenberg and Joe Grue. Their fourth is David Gurvich. The following deal helped the Ehrlichman squad to the upset.

Stansby and Martel play 12-14 1NT openers, so Stansby had to open 1♣. Martel's attempt at preemption was brushed aside by Ehrlichman. He ducked the opening lead of the ♠K, won the spade continuation and ended with 11 tricks when North was squeezed on the run of the diamonds. Plus 110 at one table and 660 at the other was good for 13 IMPs to the underdogs.

Record penalty?

John McMurdie's team was signing up for a bracketed knockout event at a Las Vegas regional, but in listing the total masterpoints for the team, someone left off a zero -- the total was 1500 instead of 15,000. Director Tom Quinlan had set up a penalty provision for getting into the wrong bracket -- 3 IMPs for each percentage point.

When the mistake was discovered, the decision was that there had been an 85% error. So although McMurdie and company won their first match by 27 IMPs, it went on the scoreboard as a loss by 228 IMPs. Sounds like a record to us.

see much difference in the structure of constructive bidding."

Ivar never lost his interest in bridge even though he dropped out of the big time for more than three decades. "I was trying to make a career in math. I had a wife and stepdaughter to care for. When I play bridge I am serious about it -- I always want to play well. When I play I want to be successful. My other activities prevented me from playing the type of bridge I like to play."

He credits two persons for his return to the game — Adam Wildavsky and his constant companion, Jeanne Rymer.

"Jeanne thought I needed some intellectual relaxation. She encouraged me to return to the game even though she hasn't played in many years.

"And, in a way, I met Adam through Edgar Kaplan. Edgar and I were close friends for more than 50 years -- ever since we used to play back when we were at Cornell. I attended the Kaplan memorial service in New York. Adam came over to me and said he knew I liked the Kaplan-Sheinwold bidding system. He told me he was doing some work on the system as played by Kaplan and Norman Kay and asked if I'd like to play it with him sometime. So here we are, playing together in the Spingold."

Stakgold has been involved in the K-S system from the beginning. When Kaplan and Alfred Sheinwold were putting their system together, they frequently conferred with Lenny Harmon and Stakgold.

Stakgold learned something about cards and how they work from his mother when he was 12 or 13, but he didn't take up bridge until he went to Cornell. When Kaplan returned to Cornell in 1946 after his war service, "he helped me a lot," said Stakgold. "We went to the local duplicate where he was very good to me, even though he already was playing at a much higher level than I. Bridge was the big thing at Cornell at the time -- any time you would go into the student union you'd see five or six tables of rubber bridge in play."

He characterized Kaplan as "the brightest person ever to go to Cornell and not graduate. Kaplan always was very quiet, with a wonderful sense of humor. Not the pun type like Alan Truscott, you know. Edgar's jokes were the kind you might have to think about for a moment. For instance, here is what he once said about me -- 'I love you as a teammate, you're such a devout coward'."

Kaplan was majoring in chemistry, and Stakgold started in electrical engineering but switched to math when he went after his doctorate at Harvard. "I discovered I had no talent for anything mechanical or electrical, so I switched. To this day I can't fix anything around the house."

Stakgold stayed in the Boston area until 1956 where he was an assistant professor at Harvard. At the special party thrown in his honor when he left Boston, Stakgold was extolled by Boston's Larry Weiss as follows: "Ivar Stakgold is one of the best players in the country -- but he's not all that good in the city."

1925 was a special number to Stakgold, Kaplan and Truscott. "We once formed a 1925 team for a Reisinger knockout in New York. In addition to the three of us we also had Dorothy Truscott and Andy Gabrilovitch. No, we didn't win."

He spent three years in Washington with the Office of Naval Research, then followed that with eight years at Northwestern University in Chicago as head of the math department. His wife Alice contracted cancer in Chicago, and she wanted a change of venue after she recovered. The mothers of both Alice and Ivar

lived on the East Coast, so they moved to Delaware where he was math department head at the University of Delaware until his retirement. Alice died in 1994 when a second kind of cancer assailed her.

"One of the biggest moments in Alice's life was a bridge happening. She and I played as partners in the Master Mixed Teams in 1969, and we won - Alice was a North American champion. That was a glorious moment for her."

Ivar made an interesting observation about college professors. "The GI Bill of Rights changed the complexion of American colleges. Not all professors are from the aristocracy any more. A mechanic with a good brain can go to college on the GI Bill and become a professor or even a head of a department. That bill is one of the nicest things about democracy."

Ivar was born in Norway, but when he arrived in the United States, the immigration officer said, "You don't look Norwegian." He isn't -- his family is from Russia originally. In fact that's why he could get into the United States before his parents -- he was born in Norway, so no problem. His parents' passports were Russian, so they had to wait.

Ivar's record in North American events is enviable. He has won six championships, including a Vanderbilt, a Chicago (now called Reisinger) and a Spingold. He was on the runner-up Bermuda Bowl team in 1959 and he also represented the United States in Turin in 1960.

And now he's back after more than three decades. "I'm enjoying being back. Bridge is still a great game. The question is: am I good enough to play at the top level? I don't know yet -- and I don't know if I want to work that hard."

The Facts: 6NT made six, plus 980 for E/W. The Director was called after the hand was over and was told that the 4♥ bid had been very slow. East stated that she had a real problem deciding what to bid. The E/W agreement was that 4♥ showed no slam interest, 3♥ showed slam interest and 3♣/3♦ showed a singleton. The Director ruled that a slow 4♥ indicated that East had alternative bids, all of which would show more strength. The slowness suggested the possibility that further action could be appropriate. The contract was changed to 4♥ made six,

plus 480 for E/W (Law 12C2).

The Appeal: E/W appealed the Director's ruling. West estimated that the 4♥ bid took 10-15 seconds, but said his partner was a very deliberate bidder so he did not think it was a hesitation. He said he expected 13-14 HCP and was surprised when she had as much as she did. He said he would have signed off in 5♥ if she had bid 5♦. North believed the break in tempo had been 25-35 seconds.

The Committee Decision: The Panel decided there had been a hesitation that demonstrably suggested further bidding and that pass by West was a logical alternative. The contract was changed to 4♥ made six, plus 480 for E/W.

The Facts: 5♦ doubled went down one, plus 100 for E/W. The Director was called when West bid 4♠. The Director determined that East broke tempo before doubling 4♦. It was also agreed that there was a slight hesitation after the first pass by West. The Director ruled that passing 4♦ doubled was not a logical alternative for West and allowed the table result to stand.

The Appeal: N/S appealed the Director's ruling. The Stop Card had not been used before the 4♦ bid. N/S estimated that West's first pass took 15 seconds (E/W believed it was 10 seconds); both sides agreed it then took 6 seconds for North to pass; N/S estimated it took East 1 minute to double (E/W believed it had been 20 seconds). N/S seemed most concerned that E/W correct their tempo problems. Neither North nor South thought a pass by West after 4♦ was a logical alternative (they objected to West's pass of 4♦ rather than a 4♠ bid). N/S also expressed concern that pass by East at her second turn might be a logical alternative and stated that East had fingered the bid box before doubling 4♦.

The Panel Decision: South's failure to use the Stop Card (by so doing he may have made it more difficult to judge the elapsed time) helped create the dispute on the timing over 4♦. In any case, the Panel was not convinced an unmistakable hesitation occurred by West over 4♦. By N/S's own admission, West's pass of East's double was not a logical alternative despite East's break in tempo. The Panel decided that a pass by East over 4♦ was not a logical alternative and any action (double or 4♥) would have led to West bidding 4♠. Hesitations by this level of player (approximately 100 masterpoints) are less likely to transmit information that "demonstrably" suggests one action over another. The Panel allowed the table result of 5♦ doubled down one, plus 100 for E/W, to stand. Since N/S (experienced players, 1150 masterpoints each) presented no argument to reasonably expect the Panel to decide in their favor, the appeal was determined to lack merit and N/S were assigned an Appeal Without Merit Penalty Point.

Bone density test today

The sponsor of today's Stratified Senior Pairs - the Preventive Medicine and Rehabilitation Centers -- will conduct bone mineral density tests today from 9 a.m. to 5 p.m. at the Marriott Rivercenter.

The tests will be conducted near Salon E, where the event is to be played. A physician will be available to discuss the results. The bone density test costs \$20 and takes five to 10 minutes.

The test is recommended because of statistics regarding osteoporosis and osteopenia. Fifty percent of women and 15% of men will have a fracture related to osteoporosis some time in their lives. Approximately 1.5 million men and women suffer fractures each year, including 300,000 with hip fractures, of which 60,000 will die within the year.

Diagnosis is accomplished by determination of bone density, but only about 7.5% of people who suffer from osteoporosis have been diagnosed.

As you can see, the spade suit lies pretty well for declarer, who can hold his losses to one spade, two diamonds and the ♥A. Kantar demonstrated that he needed no luck to take nine tricks.

East led a low club, and Kantar won in dummy to play a heart to his king.

East won the ♥A and returned a low diamond. Kantar won the ♦A, ruffed a heart in dummy and followed with a club to the queen, heart ruff, club to the ace, heart ruff. He then exited with a diamond, hoping the suit might be blocked or that the defenders would give him something useful.

In fact, the defenders cashed two diamond tricks, leaving Kantar, in the three-card ending, with ♠ A 8 5 opposite ♠ Q 10 9. Whatever the lie of the spade suit, he was assured of two more tricks — a guaranteed plus 140.
